

## Performance summary:

- 12,647 participants (excluding children accessing early connections) have had an approved plan since July 2013. 12,104 of these continue to be active.
- 7,696 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- In the current quarter, 340 participants have entered the Scheme and there are 191 children accessing early connections at the end of June 2022.
- 2,381 plans have been reviewed this quarter.
- 491 access decisions have been made in the quarter, of which 343 met access and are still active.
- 49 (14.4%) of the new active participants this quarter identified as Indigenous, taking the total number of Indigenous participants in TAS to 1,128 (9.3%).
- 6 (1.8%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) <sup>3</sup>, taking the total number of CALD participants in TAS to 377 (3.1%).



- Total annualised plan budgets at 30 June 2022 were \$957m and payments from 1 July 2021 were \$745m.
- The number of active providers at the end of June is 1,524, growing by 4% in the quarter.
- Utilisation was 77% from 1 October 2021 to 31 March 2022, with no service district in Tasmania more than 10 percentage points from the adjusted national benchmark.
- There were no service districts where the top 10 providers were providing more than 85% of payments.



<sup>&</sup>lt;sup>3</sup> Total plan inflation consists of plan budget changes occurring at plan review, as well as changes occurring within a plan, between reviews. Previously the NDIA has not included the additional percentage changes in plan budgets that occur within a plan and before the scheduled review, when reporting this metric, and this has underestimated the extent to which plans have increased.

<sup>4</sup> A minor change in methodology was applied to the exclusion of zero dollar plans in the inflation calculation. This change has resulted in small one-off changes in some of the historical inflation rates.

<sup>&</sup>lt;sup>5</sup> Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).

## Summaries by service district



- TAS North has the highest number (3,474) of active participants, while TAS South East has the lowest (2,700).
- The average annualised plan budget at the end of June for active participants is \$79,000 (\$53,300 for participants not in SIL and \$382,700 for participants in SIL).
- The average payment for the 12 months ending 30 June 2022 is \$65,500 (\$39,300 for participants not in SIL and \$365,200 for participants in SIL).
- TAS South West has the highest average annualised plan budgets and payments across all participants.
